1. No amount is refundable, if students leave the school after admission due to any reason.
2. Composite School Fee : Tuition Fee (Facilities: Computer Lab, Sports & Games, Smart T.V. Classes, Science Lab, Library & others)
3. Education Extention : Fire Safety, Electricity & Generator, Web Maintainence, Building Maintenance & other Facilities.
4. Fee is charged for 12 months from April to March whether the student joins the school on the date or not.
5. If fee is not paid by the above date, will be accepted with fine of Rs. 10 per day till the end of the month, in next month fine will be charged Rs. 200.
6. Continuous delay in Six months, fee payment will render the student's name liable to be cut off from rolls.
